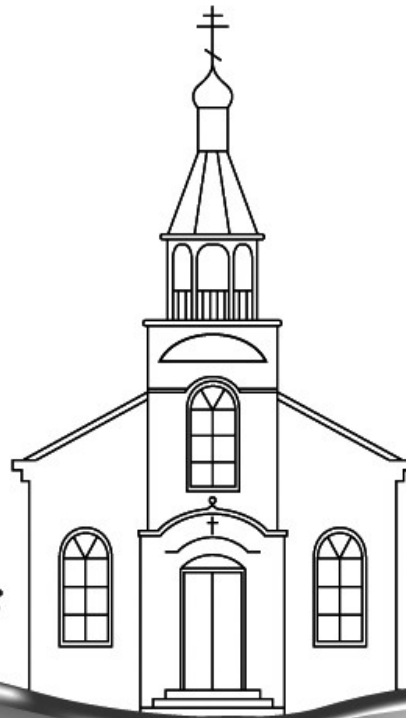

Application for Parish Membership

ABOUT PARISH MEMBERSHIP AND THIS APPLICATION FORM

The rules governing parish membership are set out in the Normal Parish By-Laws (“the By-Laws”) of the Russian Orthodox Church outside Russia. Paragraph 12 of the By-Laws stipulates that any person wishing to become a member of a parish must make a written application to the Parish Council. To facilitate this process, our parish has developed an *Application for Parish Membership* form.

The form assists both the Parish Council and prospective members by

- Employing a simple standard format for the obligatory written application
- Providing clear and consistent advice to prospective members with regard to the obligations of a parish member
- Gathering information necessary for the Parish Council to properly consider the application

A person may become a member if they

- are an Orthodox Christian
- have reached the age of 18 years
- pay the established membership dues
- make their confession and take Holy Communion not less than once a year, and
- tend to the moral and economic welfare of the parish

The By-Laws make it clear that membership dues must be paid annually and that parish members must confess their sins and receive Holy Communion at least once a year. In view of this, members are also asked to complete the *Application for Parish Membership* form upon annual renewal of membership. Completion of the *Application for Parish Membership* form each year has the added benefit of ensuring that parish records are up-to-date and that personal details remain correct.

The annual membership fee is \$20.00. Membership is granted for a calendar year; that is, from January to December. New members gain the right to vote only after 6 months of membership. Those new members who transfer membership from another parish of the Russian Orthodox Church outside Russia may vote immediately.

The By-Laws indicate that parish members may lose voting rights if they

- live in a marriage-like relationship without Church marriage
- are engaged in ignoble business, or
- are convicted of criminal offences

Parish membership may be lost if a parish member

- Is found disloyal to the Russian Orthodox Church Outside of Russia and to their parish;
- deliberately neglects Church rules and obstructs lawfully adopted resolutions of the parish meetings and the instructions of the Church Parish Council;
- has violated the good order and decorum in the church
- is found to be engaged in some ignoble occupation.

Any concerns that individual members may have with regard to their voting rights or membership should be discussed with the parish priest.
